- The workshop will be run for 29 weeks, commencing on 16 May 2024 and concluding on 28 Nov 2024. The workshops will be conducted weekly on the following days 16-May, 23-May, May30, 06-Jun, 13-Jun, 20-Jun, 27-Jun, 04-Jul, 11-Jul, 18-Jul, 25-Jul, 01-Aug, 08-Aug, 15-Aug, 22-Aug, 29-Aug, 05-Sep, 12-Sep, 19-Sep, 26-Sep, 03-Oct, 10-Oct, 17-Oct, 24-Oct, 31-Oct, 07-Nov, 14-Nov, 21-Nov, 28-Nov

2. Fees and Payment

Client agrees to pay a total fee of R 1500 monthly. To be paid in advance

- Payment Schedule:
 - 6 x monthly payments of R1500 at the beginning of every month on presentation of invoice.
 - Full payment at discount rate of R 8 000.00 due before the course begins

3. Cancellation Policy

a) **Cancellation by Client:**

- If client wishes to cancel a workshop session, they must provide written notice to Provider at least 1 month in advance.

- Full payment is non-refundable.

b) **Cancellation by Coach:**

- Coach reserves the right to cancel or reschedule a workshop session due to unforeseen circumstances such as illness, inclement weather, or other emergencies.
- In the event of a cancellation by Provider, Provider will make reasonable efforts to reschedule the session at a mutually convenient time or provide a full refund of any prepaid fees.
